

## Adult Day Centers in Vermont

Adult day centers: provide a safe, supportive environment where participants can receive a range of professional health, social and therapeutic services; are designed to provide continuing opportunities for personal enrichment through group involvement outside the home, and allow participants to continue living at home for a longer period of time than would otherwise be possible; provide respite, support and education to families and caregivers. Services are furnished on a regular basis, allowing for flexibility in scheduling to meet individual needs. Adult day participants receive individual attention and services that may include professional health care services, nutritious meals, personal care, and activities designed to foster independence. Transportation is available to many centers.
