Katherine Paterson is the author of more than 30 books, including 16 novels for children and young people. She has twice won the Newbery Medal, for *Bridge to Terabithia* in 1978 and *Jacob Have I Loved* in 1981. *The Master Puppeteer* won the National Book Award in 1977 and *The Great Gilly Hopkins* won the National Book Award in 1979 and was also a Newbery Honor Book. For the body of her work she received the Hans Christian Andersen Award in 1998, the Astrid Lindgren Memorial Award in 2006, and in 2000 was named a Living Legend by the Library of Congress. Katherine currently resides in Montpelier, Vermont.
